

Chitosan Dressing Instructions

【Product Name】 Chitosan Dressing

【Models and Specifications】 Chitosan dressings are available in 5g/patch, 7g/patch, 15g/patch, 20g/patch, 30g/patch, 35g/patch, and 50g/patch sizes, with a tolerance of $\pm 9\%$. Special specifications are available upon request.

【Product Performance, Structure, and Composition】 Chitosan dressings consist of a non-woven backing layer and a dressing. The dressing is composed of purified water, carbomer, and trehalose; the non-woven backing layer is a blend of chitosan fibers and non-woven fabric. The ingredients in the chitosan dressing are not absorbable by the human body and are sterilized by irradiation. The product is supplied sterile.

【Key Performance Indicators】

1. The cytotoxicity of the materials used in the product should not exceed Grade II;
2. The product should not exhibit delayed hypersensitivity reactions or intradermal irritation;
3. Sterility: Sterile after irradiation sterilization.

【Scope of Application】 For covering and caring for non-chronic wounds. [Contraindications]

1. Use with caution if you have allergies.
2. Do not use with pregnant or lactating women.
3. Use with caution with children.

【Instructions】 Remove the clip and push the dressing in the direction of the arrow onto the non-woven medical cloth, allowing it to absorb completely and evenly. Remove the non-woven medical cloth and unfold it. Apply to the face for 15-20 minutes each time, once daily, or as directed by a physician.

【Precautions】

1. Do not use if the product has expired.
2. This product is sterile. Please carefully inspect the inner packaging before use. Do not use if it is damaged or contaminated.
3. This product is for single use only. Reuse is strictly prohibited. Dispose of after use.
4. Please read the instructions carefully before use.
